The Atlanta Open would see increased registration as skaters would come to try out the venue and ice prior to Regionals. This could potentially bring significant financial benefit to the club. We want to solidify our position in the region as a club that can host high quality competitions. Skaters and coaches would not incur additional travel expenses or require as much time away from school to compete.

This will require significant volunteer support and time. We are confident that we can meet the needs of a large event and provide a strong experience for all participants. Bids are due January 15th, 2020. Clubs will be notified the week of February 15th if selected, and locations will be announced by the end of February.
